We are currently working on the digitalization of the anonymous questionnaires (which are a translation from English and an expansion of the text originally -2006- published by the US government) of the Italian TIs adhering to Acofoinmenef and to the Movimento Ampio against technological, electronic, psychological and mental torture (over 105 to date). We improved and expanded the U.S. Government Questionnaire, which was removed from the Internet in 2006.

All questionnaires collected since 2006 are archived in paper form and stored anonymously on the cloud, the link of which can be delivered to the AG if it deems it necessary. The undersigned, who are called TARGETED INDIVIDUALS (TI) in all countries of the world where there are tens of thousands of other people who report what the undersigned report, are part of various associations and collectives that publicly report these phenomena in Italy.

Given that the current level of technology and telecommunications in particular allows intercontinental transmissions, it is believed that they are competent for the crimes reported here, the AGs where the people, men and women, who suffer the effects of these technologies reside and live associated with the instruments commonly called -psychotronic weapons- which are precisely the object of the TIs.

First of all we want to remember some people, like us and at the time in contact with some of us, who are **deceased** also as a consequence of the treatments they had been subjected to and continuously reporting for years: Paolo Sacchetto (resident in Lanusei BL+2007), Maurizio Bassetti (+2010), Patrizia Padovani (Verona + 2024), the first two members of **AVae-m** and the third to **Acofoinmenef**, and also other TIs of whom we have learned over the years that they died prematurely: Francesco Mastrogiovanni (+2009), Claudio Frisardi (+2006), Francesco Abbatipietro (+2009).

One of the reasons why the technology used for mind control has remained a state secret is the complicity of part of the psychiatric world, in particular thanks to the great media prestige given to him by the diffusion of the *Diagnostic Statistical Manual* produced by the American Psychiatric Association (APA) in the United States and printed all over the world. We want to remember that these things are recognized by the judiciary, but they are not scriptural texts but rather products of a category substantially devoid of scientific evidence. The global mental health market will reach 560.33 billion dollars by 2030, driven by growing awareness and the aging population – (Fromhttps://www.businesswire.com/).

The world of cinema itself has often been interested in the topic of mind control. Just think of the film *The Manchurian Candidate*, presented out of competition at the 2004 Venice Biennale, <u>remake</u> from the 1962 film *Go and kill*(*The Manchurian Candidate*) by John Frankenheimerwhich talks about the use of these tools by political power. The political world itself is sufficiently affected by the criminal world (euphemism) to give credibility even to these fictions, which in reality are not fictions. Many TIs, including some of the present complainants, are falsely diagnosed with psychiatric pathologies induced by the system used in the torture reported here, and further aggravated by the repeated psychological abuse and harassment perpetrated over the years through organized gang stalking and collateral crimes. But when does schizophrenia really arise? According to WHO estimates, there are approximately 24 million people affected by schizophrenia in the world, in Italy there are approximately 245 thousand. The disease is insidious because it generally begins in late adolescence, rarely in childhood, and lasts a lifetime. It usually manifests itself between the ages of 18 and 28. (NOTE nr.1)

It is however probable if not certain that in the Italian national context, TIs are victims chosen by criminal organizations that, using these weapons, appropriate not only confidential information, but also money, real estate and economic assets., but also of the power of life and death of people, thus constituting an illegal and subversive system because it undermines the very foundations of civil coexistence between citizens, women and men, but also children, with complete impunity.

Not by chance, just to cite an example, one of the ITs that at the last moment<u>she no longer</u> wanted to sign this complaint due to pressure from her husband, is an IT worker living in Turin, where she has already turned to the courts so far without success, who owns land in a

Southern region. A typical case.

**Many-and others-and YOU**residents in Italy or Italians abroad, contacted and known by us, would be very happy to collaborate in the repression of these phenomena, if only the Judiciary had expressed an explicit interest in doing so.

We write this without any intention of offending or ironically regarding your function, role and personality, individual, collective and legal.

#### 2 - PSYCHOTRONIC WEAPONS AND SECRET RESEARCH

In the Italian edition of Mojmir Babaceck's text "The Psychotronic Threat to Freedom", it can be found on page 14the explanation of the attacks that have been denounced by numerous American and Canadian diplomats: "The use of modern neurotechnology can be applied to masses of people or individuals at any time. Already in 1999, Russian politician Vladimir Lopatin wrote in the book "*Psychotronic Weapon and Russia's Security*" that psychotronic warfare "*is actually taking place without a declaration of war*" and in May 2024 the U.S. House of Representatives Committee on Homeland Security will hold a hearing entitled "*Silent Weapons: Examining Foreign Health Incidents, Targeting Americans at Home*", which discussed the classification of these weapons and their use against diplomats, security agents and ordinary citizens of the United States (Havana syndrome). There is no guarantee that the use of such neurotechnologies against individuals or masses of people will stop as long as their classification continues."

In relation to Havana Syndrome, "IAH" stands for "Intrusive Auditory Hallucinations." This term has been used to describe one of the symptoms reported by U.S. and Canadian diplomatic officials and personnel who experienced neurological disturbances in several locations, including Havana, Cuba.

In fact, even before the international media recognition of the Havana syndrome, several things were known:

THE MK ULTRA PROJECT ALREADY EXISTED, STARTED IN 1953 IN THE UNITED STATES. It was the code name given to an illegal and clandestine program of experiments on human beings studied and implemented by the CIA during the fifties and sixties of the twentieth century, which had the aim of identifying drugs and procedures that, integrating other torture techniques, made the people who were subjected to them confess, then over the decades it was developed using electromagnetism, ultrasound and nanotechnology.

Initially called "Project Bluebird" and later "Project Artichoke", it was finally named "MKUltra" from the German ("Project Mind Kontrolle Ultra") on April 13, 1953 by CIA Director Allen Dulles, who had complained that he "didn't have enough human guinea pigs to test these extraordinary techniques" (from the English "not having enough human quinea pigs to try these extraordinary techniques").

MKUltra consolidated the various federal mind control and interrogation projects into one program, using a very large number of resources (money and scientists) throughout the United States and Canada. During the 1960s it was scaled back and then officially stopped in 1973 due to the scandal, with CIA Director Richard Helms ordering the destruction of all documents but without complete success.

MKULTRA WAS OFFICIALLY SHUT DOWN IN 1973 but in reality the tools and technologies used by the CIA in this project have always continued, and continue to operate today, all over the world. THE EXPERIMENT of the scientist ALLAN FREY IN 1960 who worked for years in the *General Electric's advanced electronics center* of Cornell University, and made this discovery in an almost

coincidence: a man who was measuring radar signals in a nearby location, belonging to the same university center, told him that he was able to perceive the sound emitted by the radar. Frey went there, performed a series of experiments and proved that it was true. He thus started a series of innovative studies on the effects that microwaves could have on the human brain: it was discovered that they hit the brain at the height of the temporal lobes, where the auditory cortex is located, triggering the perception of disturbing sounds and not only by those with hearing, but also by deaf people. From there called the "Frey effect" or "microwave auditory effect".

Researcher José Delgado had already used these techniques on some bulls. Demonstrating that he could control their very will.

In the 70s, researchers Burton first (1972) and then Delgado (1976) proposed to the United States Congress to adopt these technologies to control the thoughts and behaviors of "borderline" people, "drug addicts", "subversives", "criminals".

In the 1980s these techniques, together with the use of radio transmissions to stun and psychologically annihilate prisoners (used in Germany since the 1970s, and then according to some testimonies in our possession, also in Italy, as well as officially in Sweden since around 1985), were extended to maximum security prisons.

## United States Patent<u>6,488,617</u> (December 3, 2002),**Method and Device** for Realizing a Desired Brain Stimulus

**Abstract:**Method and Device for Producing a Desired Brain Stimulus in an Individual The patent contains means for monitoring and analyzing the brain state while a set of one or more magnets produce fields that alter the normal state. A computational system alters the various parameters of the magnetic fields so as to collapse the gap (Editor's note: immediately transition into the desired mental state) by switching to the desired brain stimulus. This feedback process operates continuously until the gap is minimized and/or removed.

## United States Patent<u>6,239,705</u> (May 29, 2001),Intra-oral electronic monitoring device

**Abstract:**An improved, non-surgical, biocompatible electronic tracking device is provided in a housing in which it is placed intraorally. The housing contains microcircuits. The microcircuits include a receiver, a passive mode to active mode activator, a signal decoder to determine positional correction, a transmitter, an antenna and a power supply. Upon receipt of a coded activation signal, the decoder position correction signal is recalled, resulting in a position correction. The transmitter then transmits a homing signal through the antenna to be received from a locator.

**United States Patent**<u>6.091.994</u> (July 18, 2000),**Pulsative manipulation of the nervous system** 

**Abstract:** Method and apparatus for manipulating the nervous system by imparting

pulsations to the subject's skin at a frequency that is appropriate for the state of change for a given sensory resonance. Currently, two main sensory resonances are known, with frequencies near 1/2 Hz and 2.4 Hz. The 1/2 Hz sensory resonance causes relaxation, drowsiness, a tonic smile, a "knot" in the stomach, or sexual arousal, depending on the specific frequency used. The 2.4 Hz resonance causes the slowing of some cortical activity.

## United States Patent<u>6,052,336</u> (April 18, 2000),**Apparatus and method of sound** broadcasting Using ultrasound as a vector

**Abstract:**An ultrasound source transmits an ultrasonic signal that is amplitude and/ or frequency modulated with an input signal information from an input source information. The modulated signal, which may be amplified, is then transmitted through a projector, whereupon an individual or group of individuals located in the transmitting region and can detect it as audible sound.

## United States Patent <u>5,539,705</u> (July 23, 1996), Ultrasonic voice translator and communication system

**Abstract:**A wireless, radio frequency nondetectable communication system for converting audio signals, including the human voice, into electronic signals in the ultrasonic frequency range, transmitting the ultrasonic signal by acoustic pressure waves through a computer medium, including gases, liquids and solids, and converting the ultrasonic acoustic pressure waves back into the original audio signal. This invention was made with the support of the Government under Contract DE-ACO5-840R2l400, from the United States Department of Energy to Martin Marietta Energy Systems, Inc.

## United States Patent 5,507,291 (April 16, 1996), method and related equipment for remote determination of information to detect the emotional state of people

**Abstract:**In a method of remotely determining information about a person's emotional state, waveform energy having a predetermined frequency and predetermined intensity is generated and transmitted wirelessly to a subject at a remote location. The waveform energy emitted by the subject is detected and automatically analyzed to derive information about the individual's emotional state.

## **United States Patent** 5,159,703 (October 27, 1992), **silent subliminal control system**

# 4 - INSTITUTIONAL POLITICAL RECOGNITION IN 1995 BY FROM THE US PRESIDENT TO THE COMPLAINTS OF THE COMMITTEE OF SURVIVORS OF MIND CONTROL EXPERIMENTS ON HUMANS

So much so that in 1995 the President of the United States of America, Bill Clinton, publicly denounced these experiments on October 4, 1995 after the initiation of a Presidential Inquiry into the allegations of the Committee of Survivors of Mind Control Experiments on Humans. The phenomenon denounced by the US President involved several thousand people but the number of associations existing in the world today, and the lists released by them, lead us to think that the Victims (or rather the TIs) in the world are several hundred thousand people.

In the magazine Rassegna dell'Arma dei Carabinieri nr.2 of the year LXII (April/June 2014), publicly available, the "philosophy" of brainwashing or mind control operated in a sectarian context by criminal organizations is highlighted;

"mental manipulation, plagiarism, illustrates how the designated victim, through a process of submission of the will, is induced to commit actions that he would never have carried out in conditions of "normality". The mental control of the individual and the influence on his free will strongly destabilize the "sense of self", to the point of inducing the subject to isolate himself, detaching himself even from his dearest affections. The personal identity itself is often strongly compromised and replaced, in most cases, by another one shaped by the drastic change in one's behavioral habits, following the insertion into the new social "group". It is precisely through the analysis of this psychological conditioning, so-called "brainwashing", founded essentially on persuasive technique and never in the form of coercion".

However, the same techniques are practically impossible to avoid for those under REMOTE mind control by strangers. The judiciary and criminologists tell us nothing about this. Why?

It is not possible to assume that in ITALY these inhuman weapons are used ONLY for scientific purposes and experiments NOR is it possible to assume that they are used EXCLUSIVELY by bodies or entities of the STATE, while it is absolutely indisputable that those who know these weapons are certainly the State military bodies, given that these are tools and techniques that have even been patented by the American "ally".

#### 5 - DOCUMENTATION ON THE WEAPONS PHENOMENON **PSYCHOTRONICS**

**Documentation in Europe, USA and Italy**, began to circulate in the 90s even before Bill Clinton's statements, emerging from counterterrorism news.

In 1988 during a criminal trial in **Germany** for a terrorist attack carried out by two Palestinians, who were later arrested, who reported having been convinced by mind control techniques to make confessions that they later retracted. (German daily newspaper Frankfurter Allgemeine Zeitung 18-11-1986).

In an interview by Igor Smirnov for the Moscow News newspaper, the deputy director of the Medical Research Center of the factory producing for the Russian Department of Defense, Vladimir Niestierov, told them that Miranda is produced under American license on the basis of the agreement signed by the KGB and the CIA on September 24, 1990 and which provides for joint research in the field of psychotronics (from chapter 9 of Mojmir Babacek's book, The Psychotronic Threat to Freedom, Italian edition 2024). The same text reports this information on the Waco episode (USA):

"The well-controlled game of publications on this topic continued in 1993 and 1994, when the American weeklies Defense Electronics (Defense Electronics, July 1993, "DOD, intel Agencies Look at Russian Mind Control Technology, Claims FBI Considered testing on Koresh), Newsweek (Newsweek, February 7, 1994, "Soon Phasers on Stun") and Village Voice (Village Voice, March 8, 1994, Mind Control in Waco) published information that Igor Smirnov of the Moscow Medical Academy had demonstrated to US intelligence and FBI experts a device capable of subliminally implanting thoughts into people's minds and thus controlling their actions. According to these reports, the FBI was considering using this device against David Koresh during the siege of him and his religious sect in Waco."

The Waco siege was a test of American and Russian intelligence collaboration in mind control. The fire caused by the intervention of special forces caused 76 deaths, including 25 children.

An important scientific text on the subject is David Gujat "Some aspects of electromagnetic weapons against people" – Synopsis prepared for the International Red Cross Symposium- "The average profession and the effects of these weapons" - February 1996 (study from the 40s to 1995) (see http:// www.deepblacklies.co.uk/some\_aspects\_pr.htm )

During the last war in Iraq, an Iraqi minister captured by the American armed forces was found to have such a device.

During Italian television broadcasts *History is us*(RAI 3) of 14-12-2003 and *Stargate*( LA 7) of 4-5-2003 it was learned that Timothy James McVeigh (Lockport, 23 April 1968 - Terre Haute, 11 June 2001), sentenced to the electric chair for the massacre in Okhlaoma city (USA) on 19-04-1995 in which 168 people died, including 19 children, and 672 people were injured, had been subjected to microchip **implantation** and to these treatments during detention, before being executed on 11-06-2001.

# 6 - TORTURE IN ITALY – FROM REPORTED CASES ON PRISONERS TO THE DISSEMINATION OF TECHNIQUES TO ORDINARY CITIZENS MODERN TORTURE TECHNOLOGY

The first cases reported since 2006 and the phenomenon of the well-known tortures that came to light in 1982 in Italy (in particular the case of Cesare Di Lenardo at the Padua Police Headquarters, which led to a trial against some police officers and in particular the Hon. Salvatore Genova) were discussed in the book edited by the lawyer Romano Nobile in 2006, "*Torture in the beautiful country*", published by Malatempora in Rome in two editions (see. <u>NOTE nr.2</u>) But the events that took place in Genoa during the demonstrations against the G8 in July 2001, which were extensively covered by the judiciary, have had international resonance. And in recent years, numerous cases have come to light of real systematic mass beatings carried out by even large groups of prison officers in numerous prisons (the latest being the arrests in November 2024 relating to the prison in Trapani).

In Italy, in the second half of the 90s, the AISJCA was founded in Turin by Dr. Anna Fubini, who created a research group.

In Italy, apart from an article that appeared on "*The Press*" in the sixties, in relation to the disorders suffered by the wife of an engineer, this phenomenon had never been spoken of.

In the Annual Report of the Privacy Guarantor, Stefano Rodotà, of 2004, on pages 104-105 we read: "One of the most recent areas of use of this technology concerns the subcutaneous implantation of RFID device of even on people. There is already news of the start, also in Italy, of techniques for inserting microchips in the human body for various purposes: for example, for the purpose of

store and make available, when necessary, information on the patient's health status; in order to verify access to certain reserved places; again, to ensure rapid payments in commercial transactions of various types. 15 THE ACTIVITY CARRIED OUT BY THE GUARANTOR Public consultation 104 II Subcutaneous implantation of RFID tags The sensitivity of such interventions is quite evident, so much so as to raise questions about the repercussions that the related treatments may have on the dignity of the person (art. 2, paragraph 1, of the Code)."

Since 2005, AVae-m (Association of Victims of Electronic-Mental Weapons) founded on 5-9-2005 by Paolo Dorigo and Maurizio Bassetti conducted

"a hard fight to denounce technological abuses on people, forms of torture and slow murder that are practiced with non-lethal weapons, psychotronic weapons, electrodes implanted in the human body without any authorization of the people interested in treatments, (which also have an experimental and profit profile), and against pronouncements of the Council of Europe (in particular the reports on the matter by Rodotà Capurro of 2006)"

(from the -public- document of Acofoinmenef of 12-5-2013)

One of the first cases reported in Italy was that of Maurizio Bassetti (+2010, Rome), who was chief economist at the Italian Chamber of Deputies; Bassetti was behind the dismissal of some officials of this institution, in 1992, thanks to his reports which gave rise to the "light bulb scandal" during the Napolitano Presidency; following these events he was moved to the press office of the Chamber of Deputies, after which he was attacked at home in Rome, and began to suffer these treatments, which continued until his death. Then there is the case of Paolo Dorigo, founder of AVae-m in 2005 and of Acofoinmenef in 2009, co-reporter of the present, who while he was in detention due to the proceedings for an attack on the USAF base in Aviano in 1993, brought

publicly with various hunger strikes their complaints (**NOTE nr.3**) of inhuman and degrading treatments related to transmissions, brain interference, and technological and permanent disorders, ("non-lethal" weapons).

The first association founded by the psychoanalyst was AISJCA (Italian scientific and legal association against mental, physical and technological abuse) in Turin. Anna Fubini (+2017 Turin) to talk about the case of torture reported by Paolo Dorigo, still while he was in prison (see in <a href="https://www.aisjca-mft.org/chips-viol.htm">https://www.aisjca-mft.org/chips-viol.htm</a>) through electrodes implanted in his head during a surgical operation in detention, which he denounced with over 20 hunger strikes in prison between 2002 and 2005.

Through the work of AVae-m and then Acofoinmenef, hundreds of people in Italy who were subjected to similar treatments have come to know. Most of them are people who themselves contacted Mr. Paolo Dorigo without even having met him before. One of these citizens, a young man from Udine who had lived for a certain period in Brazil, was grafted into his oral cavity. On 22-11-2020, the Acofoinmenef ex Avae-m website reported the following news:

"We publish some evidence of grafting on a Victim" (i.e. a TI) "a young Italian from the north-east, alive, who after the dental transplant (23-07-2020 in Verona) that the dentists did not recognize formally." It has greatly reduced the ailments he suffered from

The contents of the transparent envelope shown on the page reproduced above are kept by Paolo Dorigo in a small safe at the headquarters of the union where he works.

This demonstrates that mind control can be achieved through dental prostheses (and not only through the presence of galena) and not only through brain microchips or radio waves directed at the individual Target.

**Similar treatment had been reported since 2006** from a citizen who at the time lived in Pescara and was a member of AVae-m, who was then "convinced" to self-submit to TSO and to delete the site which remained online between 2006 and 2007 (OMISSIS) where she had published, with the help of Paolo Dorigo, the x-rays of the orthopantomography and other documents.

In reality, the phenomenon of TI women, in Italy and in the world, is very frequent. And it is very strange that with all the movements, parties and unions, that deal with gender violence and the defense of women, there are none committed to denouncing the electronic, technological and mental weapons, used against women themselves, and not only against deviants or presumed deviants, men.

Starting from June 2023, in his speech at the Brussels demonstration on 10-06-2023, Paolo Dorigo declared that he had recovered the memory of what happened at night in November 1995 when he was taken from his cell in Novara (special section block B) and evidently anesthetized. There is a first reference to this recovered memory in the aforementioned speech in Brussels, published on the website of the Acofoinmenef association and in the afterword of the Italian edition of the book *"The Psychotronic Threat to Freedom"* by Mojmir Babacek (ISBN 9788862340397), which reports

"While in prison, I was clandestinely implanted with means of control at the end of 1995; with these instruments, I have been prevented from freedom of thought since the year 2002.**if not before**" And

"as I remember now, already in NOVEMBER 1995, I had woken up for only 2-3 seconds before falling asleep again - while I was evidently under anesthesia - in my memory I was on a moving stretcher in a dark corridor, evidently I too had been inoculated with "MK Ultra" BEFORE the fateful 4 January 1996 when I burned myself after spilling 180 grams of butane gas from a canister on myself, in the Novara special prison. The fact was completely silenced by the Italian media".

As recently as 05/31/2024, Paolo Dorigo made public through the website of the International Resistance Movement Against Neuro Technological Torture ( neurofreedom.org ) the complaint he had sent to the UN Special Procedures Report office. Even in this complaint he declared "I was secretly anesthetized in Novara prison in November 1995. Since April 2002 I "I was secretly anesthetized in Novara prison in November 1995. I was I was auditorily tortured and with nerve pain inflicted via radio" tortured

Certainly the phenomenon of torture was born and developed in Italy around detention, but with the spread of technologies and psychotronic weapons, it has extended to the civilian population.

In Italy AVae-m and then Acofoinmenef have repeatedly published statistics of the cases recorded by these associations, of these treatments relating to the TI.

In the latest of these publications concerning TIs (see <a href="https://www.associazionevittimearmielettronica-mentali.org/STATISTICA-CASI-CENSITI-ITALIA-PER-REGIONE-07082024.pdf">https://www.associazionevittimearmielettronica-mentali.org/STATISTICA-CASI-CENSITI-ITALIA-PER-REGIONE-07082024.pdf</a> ), we are talking about 194 cases in Italy, and another 104 to be investigated, a total of 355 cases, of which 8 are foreign citizens in Italy.

The geographical distribution is uniform throughout the national territory, with peaks in some large cities (Rome, Milan, Turin, Bologna).

The professional background of the people who contacted us is mixed, but there is a significant portion of graduates (over 20%) and computer scientists or electronics engineers (over 10%). There are many women without partners in everyday life.

Several dozen are people who have direct relatives or fiancés or who have had relationships with members of the Italian police or military forces.

This is not written to smear anyone, but to highlight the great danger experienced by both the population and the members of the law enforcement agencies and the army, if the state continues undaunted in not addressing this huge problem.

There is also evidence of this in the speech that Paolo Dorigo gave at the Brussels conference in 2014(<a href="https://www.covertharassmentconference.com/2014/summary\_videos?v=Paolo\_Dorigo">https://www.covertharassmentconference.com/2014/summary\_videos?v=Paolo\_Dorigo</a>) whose statistics have been public since then (<a href="https://www.associazionevittimearmiinternonichementali.org/Table1-CHC.pdf">https://www.associazionevittimearmiinternonichementali.org/Table1-CHC.pdf</a> and on page 2 of<a href="https://www.associazionevittimearmielettronichementali.org/Table2-CHC.pdf">https://www.associazionevittimearmielettronichementali.org/Table2-CHC.pdf</a>).

In this statistic, it is mentioned 16 family members of members of the armed forces and/or police, and 3 members of the army and 3 members of the police. This information was taken from the stories and communications made both to Paolo Dorigo and to other associates, often oral, but also written, by Italian citizens and directly referring to themselves. This dataNothave been lost, so much so that at the registered office of Acofoinmenef (Paolo Dorigo's home) there are numerous successive temporal versions, in Microsoft Access format, of the Victims' database, which for privacy protection reasons have NEVER been made public.

Very often the people who report these treatments on various sites or on Facebook have been or still are or have been at the beginning of the period in which they have undergone these treatments, under the control of the **psychiatric authorities**, sometimes in compulsory medical treatment.

**That the phenomenon is not unknown**, as demonstrated by the Facebook group held by the engineer Andrea Giotti, "Mind control, artificial telepathy and covert psychological operations which collects more than **7354 participants**.

But in no case, in the face of complaints and reports of mistreatment (stalking) and torture, have the Italian judiciary or the health authorities themselves, to date, given them any response.

The undersigned had not previously had any relationship with each other prior to these treatments, following which they met thanks to the Internet; they were residents in every Italian region; they had and have different if not opposing political opinions; they were involved in the most diverse economic sectors and also in some institutional cases, which were subjected to similar treatments; and therefore the possibility of a joint complaint arose.

Following the first reports of the AVae-m (2006-2007) there was interest from jurists and

of parliamentarians, which however did not lead to a parliamentary inquiry, led to some publications, in particular Torture in the beautiful country, and to the 2007 Dossier of the AVae-m as well as to the book distributed to the **Bologna conference in 2016 (NOTE nr.4)**.

Even the President of the Republic took seriously Paolo Dorigo's request for help following the complaints that were archived (<u>NOTE nr.5</u>), and on 09-10-2006 responded with this communication ( UGG.11.2. N.860/06 ).

Citizens involved in the study of these weapons and techniques, which are a "mix" between the research started in Nazi Germany during the Second World War, and the brainwashing techniques, developed through microelectronics, known to the military and civil services in the USA and the USSR, began to contribute to these complaints in various capacities and in different ways.

This type of treatment, here denounced by the undersigned, who denounce technological torture and countless other crimes, are able to interfere with the brain, mental and physiological activities of persecuted people, constantly and cyclically causing, day after day, for a long time, even for years and decades, disorders and illnesses if not even medical pathologies, to the point of pushing some to suicide and also inciting them to murder innocent people or to cause fatal diseases.

These technological tortures consist of voices of men and women directly into the head, into the brain of the victim 24/7 (often increasing the volume of the voices), created by a super computer or artificial intelligence. Voices copied from real people or there are real operators who insult, threaten or mock the victim, sounds or noises (fake tinnitus) perceived by the victim, dreams manipulated to seem real, physical pain and even implantation of false memories in the victim.

Gen. Castello highlighted Law 374/1997 - Law 374 of 29 October 1997 banned antipersonnel mines in Italy, prohibiting "technological research, manufacturing, sale, transfer for any reason, export, import, possession of anti-personnel mines of any nature or composition, or parts thereof".

It is therefore appropriate that this complaint be followed by an ex officio judicial action to safeguard the freedom of thought of citizens and our institutions themselves.

The role of the "targeted individuals" in this investigation thus becomes that of key witnesses of a profound wound to every established principle of human civilization., see for example the statements on the subject of torture by the main international organizations.

The possibility of documenting research in the field of psychotronics**It is limited by the fact that it is covered by military secrecy**, therefore the available documents are necessarily related to research from the period and subsequently declassified.

The natural progress of scientific knowledge and the testimonies of "Targeted Individuals" suggest the current use of much more advanced technologies by some secret services, technologies about which it is only possible to speculate. Although most of the available documents are related to the use of directed energy weapons of electromagnetic or sonic nature, the possibility of the current use of new energy and information vectors such as excitations of some theorized but not yet officially demonstrated field, produced by devices resulting from extreme developments of current quantum physics such as SASER, must not be excluded.

(Ordinary Supplement n. 119) "that in item M of art.1 part 1 (m) Special equipment Categories 12,13,16,17, (18,19,20 and 21 specially built for military use) says:

#### Category 19

Directed energy weapon systems, associated or countermeasure equipment and test models, as follows, and specially designed components therefor:

- a. "laser" systems specially designed to destroy a target or to abort the target's mission;
- b. particle beam systems capable of destroying a target or causing the target to abort its mission;
- c. high-power radio frequency systems capable of destroying a target or causing the target to abort its mission;

- d. components specially designed for the detection or identification of, or defence against, systems controlled by paragraphs a., b., or c. of this Category;

- b. particle accelerators that project a beam of charged or neutral particles with destructive power;
- c. emitters of high pulsed power or high average power waves capable of producing fields sufficiently intense to render electronic circuits unusable a distant target.

#### Note 2

This category includes the following materials if the the same are specially designed for directed energy weapon systems:

- a. equipment for the generation of immediately available power, for energy storage or switching, for power conditioning or fuel handling;
- b. target acquisition or tracking systems;
- c. systems capable of assessing the damage caused to the target, its destruction or mission failure;
- d. beam manipulation, propagation or aiming equipment;
- e. rapid beam scanning equipment for rapid operations against multiple targets;
- f. adaptive optical equipment and phase conjugation devices;
- g. current injectors for hydrogen negative ion beams;
- h. "space-qualified" accelerator components;
- i. negative ion beam focusing equipment;
- j. equipment for controlling and directing a beam of

high energy ions;

k. "space-qualified" tapes for neutralizing negative hydrogen isotope beams.

ANDCategory 11(i) Electronic systems or devices, Categories 5,11,15, 18 and 21 electro-optical and photographic specially built for military use)

#### Category 11

Electronic equipment, not controlled by other categories of this List, specially designed for military use and specially designed components therefor.

#### Note This Category includes:

- a. electronic countermeasures (ECM) and electronic counter-countermeasures (ECCM) equipment (i.e., devices designed for introduce extraneous or erroneous signals into in the receivers of radar or radio communications or to hinder in another way, the any reception, operation or effectiveness of adversary electronic receivers including their countermeasures equipment), including jamming and countermeasures equipment; b. I disturb; frequency agility tubes;
- c. electronic systems or electronic equipment designed for surveillance and monitoring of the electromagnetic spectrum for information or military security purposes or to counter such surveillance and monitoring;
- d. underwater countermeasures equipment, including acoustic and magnetic jammers and deceivers, designed to introduce extraneous **signals** erroneous data into sonar receivers;
- e. data processing security equipment, data security equipment and data protection equipment safety for transmission and signaling lines, using encryption procedures;
- f. equipment for identification, authentication and loading of cryptographic keys and equipment for the management, production and distribution of cryptographic keys;
- g. #analog-to-digital converters usable in missile systems, and having one of the following characteristics:
- 1. designed to meet military requirements for ruggedized equipment, or
- 2. designed or modified for military use and belonging to one of the following types:
- a. Analog-to-digital converter microcircuits, radiation hardened or having all of the following:
  - 1. resolution equal to or greater than 8 bits;
  - 2. designed to operate at temperatures below -54°C or above +125°C:
  - 3. hermetically sealed;

electrical input, having all of the following characteristics:

- 1. resolution equal to or greater than 8 bits;
- 2. designed to operate at temperatures below -45°C or above +55°C;
- 3. containing the "microcircuits" listed in this paragraph g.2.a.

They allow in addition to the symptoms mentioned above video surveillance, mind reading, body monitoring by sending shocks, vibrations, pain and pressure of various degrees. We can define it as real psycho-physical torture.

There are also many victims of these treatments who also suffer the**organized gang stalking** that is, people who stalk or perform street theatre on the victims, (see the chapter "The guide for gang stalkers", text reported in the book *Bright Light on Black Shadows* by Rauni-Leena Luukanen Kilde (+2015), published by Bohdan Szewczyk, Poland, 2015, and which she claims was written by the British secret services). Rauni Kilde has been denouncing remote torture of defenceless citizens since she was Finland's national medical officer.

According to the authors of this collective complaint, some of whom have in the past suffered a TSO, as a consequence of individual complaints, even if for a short period, among the Italian institutions there are military and/or police organizations and services that are guilty of these treatments.

Mind control victims are thus automatically defined as mentally ill by doctors who learned the list of DSM "symptoms" in medical school. **Doctors have not been educated about the fact that patients might be telling the truth when they say they were taken against their will as guinea pigs.** for experiments in electronic, chemical, bacteriological and psychological warfare.

In the United States of America, various psychiatrists working for the secret services and in psychiatric institutions, mental hospitals and prisons, contributed to the drafting and correction of this manual.

This "Bible" of psychiatry hides the secret development of mind control technologies by labeling some pathologies that are actually caused by these technological treatments associated with particular drugs (benzodiazepines etc.) and their effects as symptoms of paranoid schizophrenia or similar.

Then there are periodic forms of media advertising mystification, which give space to the "good" aspects of the technology that is adopted in technological devices for the handicapped, the disabled, the blind, and people with prostheses.

But in releasing criminals already convicted of serious homicides, the State does not consider the dangers connected to certain choices, even if legitimate; for example, one of the perpetrators of the fires of

discos, and the author of 10 murders, Marco Furlan, already a model prisoner in the Opera prison, we read at the time that he studied at the University and the subject of his studies was the human brain; or we read about the permitted and telephone relationships between former terrorist mass murderers (the couple convicted for the Bologna massacre, Mambro and Fioravanti) and American prisoners sentenced to capital punishment for murder, which are almost legislated through associations that say nothing instead of the treatments denounced here, such as "Nessuno tocchi Caino".

In practice, the undersigned have a strong suspicion that in universities and clinics, prisoners and handicapped people are being used for experimentation in the field of mind control and neurophysiological technology..Even using technological versions of "clinical" tools such as Neuro Linguistic Programming, for example.

The matter is of an unheard of gravity because in order to "save" these people, many other citizens who should be able to live the lives of everyone else and who are prevented from doing so by who knows what legislation or authority, are driven to suicide and deprived of a normal existence, desperate for not being believed, in danger of being defined as "crazy".

Moreover, this is a way of "committing murder" without being accused. A strong suspicion of the above came from the circumstance that many citizens-and who reported such treatments, had been subjected to surgical operations under general anesthesia in life.

Despite the great difficulties, especially economic ones (at the maximum moment of visibility, in 2007 the Association had a budget of about 8,000 Euros), it was possible to produce radiological documentation of at least ten of the Victims who over time have been registered through analyses, meetings, medical visits by professionals who have made themselves available, questionnaires (taken from those used by similar Associations in the USA) of the symptoms that the Victims of these treatments experience on themselves, and publicity and reporting initiatives.

On November 28, 2006, there was also a demonstration duly authorized by the Rome Police Headquarters, a sit-in held in front of Palazzo Montecitorio. A few weeks later, the Chamber of Deputies passed the law against torture, including psychological and mental torture, but unfortunately the law was subjected to numerous amendments by the Senate of the Republic and even in this legislature the matter did not find a satisfactory legislative and legal solution.

We maintain that our Republican and Anti-Fascist Constitution does NOT and must NOT allow any "Legislator" to transform medical science into an instrument of torture for people who are, moreover, defenseless.

And this is reason enough for us to inform the Constitutional Court of this complaint as well.

## 8 - INTERNATIONAL CONVENTION AND LAW AGAINST TORTURE

Q Italy inited the INTERNATIONAL CONVENTION AGAIN

However, on 11-2-1989 Italy joined the INTERNATIONAL CONVENTION AGAINST TORTURE of 26-6-1987.

Finally on 14-07-2017 (law 110/1997) we arrived at the legislation of art.613 bis CP (see in <a href="https://temi.camera.it/leg17/post/OCD25-270.html?tema=temi/nuovi\_reati\_d">https://temi.camera.it/leg17/post/OCD25-270.html?tema=temi/nuovi\_reati\_d</a>).

In 2019, the Hon. Sara Cunial, with the proposal of (bill 391 of 20-07-2022 see in <a href="https://dati.camera.it/ocd/attocamera.rdf/ac18\_3691">https://dati.camera.it/ocd/attocamera.rdf/ac18\_3691</a>), proposed some extensions of art.613 bis CP to the cases that we set out in this complaint.

Although the matter denounced here is one that the investigating magistrates and the Public Prosecutor's Offices in Italy have not wanted to address on numerous occasions, recently in two archiving orders imposed on Mr. Paolo Dorigo, co-deponent of this case, in various courtrooms, concepts have been put forward concerning the admissibility of judicial investigations in this matter (**VENICE RG 4750/2020**hearing of 10-1-2024 referring to a complaint received by the Public Prosecutor's Office on 09-05-2022 [see.https://www.paolodorigo.it/pdf-pubblico-denuncia-PD-06052022.pdf) which filed with the simplified motivation that the hospital research in Mirano in 2015 of the reported chips had not borne fruit, and LIVORNO RG 838/2022 hearing of 01-23-2024 which filed with the incomplete motivation that the MK ULTRA project "does not appear to have had confirmation from the international scientific community", the judge demonstrated that he had not even leafed through the 101 pages of documentation from important internationally recognized newspapers attached at the hearing -NOTE nr.6). In the cited file, attached to this complaint, there are many articles that confirm our assertions. For example, the technology that Luca Berdondini, one of the founders of Corticale, a company from Genoa, which is a start up of the Italian Institute of Technology, talks about in the interview in Repubblica on 31-1-2024.

In our opinion howeverthe fact that these "treatments" are CONTINUOUS and PERMANENT - in place to this day - since their appearance in all the cases reported here, allows us to expose this complaint as valid and current and actionableAT LEAST starting from 07-14-2017, for cases initiated prior to that date.

In a country where Justice has already had to deal sadly with crimes and abuses by the police in prisons, in a country where scandalous situations involving medical centers and psychiatric clinics, or nursing homes, to give an example, have often come to light, we believe that our complaint must produce an effort and a courageous work of investigation to put an end to these aberrations.

As regards the evidentiary system on electromagnetic weapons and "domestic" subliminal messages, some people among the complainants (UB and MS) of this complaint can make available to the investigators the reports (technical consultancy by audio professionals) relating to the analysis of the frequency spectrum detected from environmental recordings. The technicians summoned for the expert assessment agreed both on the anomaly and on the very existence of the system that interfered with the frequencies of the entire house.

The effect on the home environment is also proven by various videos and images made in one's own home published on the internet by Paolo Dorigo (video in<a href="https://associazionevittimearmielettronica-mentali.org/VID\_20170503\_035605.3gp">https://associazionevittimearmielettronica-mentali.org/VID\_20170503\_035705.3gp</a>) (photo in<a href="https://associazionevittimearmielettronica-mentali.org/CasaPaolo.html">https://associazionevittimearmielettronica-mentali.org/CasaPaolo.html</a>).

It should also be remembered that the Turin-based non-profit organization Aisjca, which during thirty years of work has brought to light numerous proven cases of neurotorture and clandestine undercover clinical trials to the detriment of minors.

We also want to draw attention to the fact that these techniques and technologies are also used by criminal and mafia organizations.

The "TI:" (the victims) all report having suffered, in addition to neurotechnological torture, an impressive number of other collateral crimes against them (threats, thefts, damage, etc.).

In addition to the undersigned, we are aware and aware of this also to the detriment of hundreds of other people, often women, who are in contact with the whistleblowers, the undersigned who are afraid to report these facts.

In our opinion, these organizations that manage these technological abuses, mainly target vulnerable, weak and defenseless victims, and in addition, blaming their possible complaints for mental illness. While we know that they are not but are forcibly induced in order to annihilate the judicial reaction of the victims.

#### 9 - CURRENT RELEVANCE OF THE PHENOMENON

In the US in the recent year 2024, Congress held a session on Havana Syndrome. In the US, where many TIs have turned to the authorities and it has become known that there is an FBI database, and a lawyer Mark Zaid, who is recognized by military justice and security authorities, who has access to classified information, declared during the 2024 that there is irrefutable evidence that attests to the existence and use in various locations in the Western world and in Cuba, of neurological weapons on people.
